All vehicles must comply with Schedule A and Group 4H of the current Motorsport Australia Manual. Approved helmets and apparel, in accordance with Schedule D of the current Motorsport Australia Manual. Fuel must be in accordance with Schedule G of the current Motorsport Australia Manual. Cars must be adequately muffled. Competitors must produce a valid and current:

Motorsport Australia Competition Licence

Club Membership Card of a Motorsport Australia-Affiliated Car Club

Log Book (if issued) at document check.

CLASSES:

Class A - Production Vehicles Wheelbase up to 2150mm

- Class B Production Vehicles Wheelbase 2151 to 2390mm
- Class C Production Vehicles Wheelbase 2391 to 2574mm

Class D - Production Vehicles Wheelbase 2575mm and over

Class F - Front-Wheel Drive Specials

Class E - 4WD vehicles (which must be driven in the four-wheel drive mode throughout the competition) J = Junior

NJ = Novice Junior

M = Master (Male 60+ & Female 55+ @ Jan 1st)

Series 2020 awards will be given for highest points gained at the end of the season.

Awards for class wins, 1st, 2nd and 3rd so long as number warrant.

Points are given in relation to finishing position each round.

4 out of 5 rounds are counted. If all rounds are competed in then the worst round is dropped

SCHEDULE/ OTHER EVENT REQUIREMENTS:

Motorkhana is a short course of markers (witches hats) that must be driven around in the correct pattern without knocking any markers and as quickly as possible.

Each marker knocked will have 5 seconds added to the drivers time.

There are 9 different classes.

On sealed surfaces tyres are open however slick or full racing tyres will place the vehicle in the 'specials' class Entries will be accepted in order of receipt unless otherwise specified

The organisers may refuse any entry in accordance with NCR 83 of the current Motorsport Australia Manual.

Entries from competitors under 18 years of age must be counter signed / consented to by a parent/ guardian.

Event organisers reserve the right to cancel, abandon or postpone the event in accordance with NCR 59 of the current Motorsport Australia Manual.

Protests must be lodged in accordance with Part XII of the current Motorsport Australia Manual.

ALCOHOL, DRUGS AND OTHER SUBSTANCES

Any holder of a Motorsport Australia 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the Motorsport Australia Anti-Doping Policy and/or the Motorsport Australia Illicit Drugs in Sport (Safety Testing) Policy as published on the Motorsport Australia website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a Motorsport Australia 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a Motorsport Australia Accredited Testing Official (CATO) in accordance with the Motorsport Australia Standard Operating Procedure for Breath Alcohol Testing.
