**SUPPLEMENTARY REGULATIONS**  
**SUNDAY 1<sup>ST</sup> AUGUST 2021**

- First and foremost, it must be stated that drivers, officials and spectators **MUST** comply with all the current COVID 19 restrictions that are in place at the time of the event.
- This includes, but not limited to, social distancing and hand hygiene etc.
- All persons onsite at the event must comply with the Motorsport Australia “Return to Race” strategy which is available to download via their website [www.motorsport.org.au](http://www.motorsport.org.au).
- Competitor garages will be marked out and no intermingling between will be allowed.
- Hand sanitizer will be provided at the venue and hand washing regime must be followed.
- A COVID-19 compliance checker will be onsite and can stop the event until a non-conformance is rectified.
- Public address system will be used for drivers briefing.
- Self scrutineering forms must be completed.
- If you are unwell leading up to, or on the day of the event, **PLEASE STAY AT HOME.**

**1. THE EVENT:**

The Event shall be known as Round 3 of the “SEAC MOTORKHANA SERIES 2021”, herein after to be known as the Event.

The Multi Club Motorkhana Event will be conducted at **Mt Gambier Saleyards, Princess Highway, GLENBURNIE**. The Event will be Organised and Promoted by the South Eastern Automobile Club of South Australia Inc, PO Box 1551, Mount Gambier, and is open only to current members of SEAC and any club that is affiliated with Motorsport Australia and are holders of a Motorsport Australia Speed or Speed Junior Licence or superior.

**2. AUTHORITY:**

The Event will be conducted under the provisions of the FIA International Sporting Code including Appendices and the National Competition Rules (NCR) of the Motorsport Australia, the Motorkhana Standing Regulations. This Event will be conducted under and in accordance with any and all necessary Motorsport Australia COVID-19 Return to Race Strategy requirements at the time of this event. Guidelines for Motorsport Australia Passenger Ride Activity (MSPRA) Policy, the Motorsport Australia Come & Try Policy, these Supplementary Regulations and any Further Regulations or Instructions, which may be issued.

This Event will be conducted under and in accordance with Motorsport Australia OH&S, Motorsport Australia Safety 1<sup>st</sup> and Risk Management Policies, which can be found on the Motorsport Australia website at [www.motorsport.org.au](http://www.motorsport.org.au)

The Entry Fee is \$30.00 for adult drivers and \$15.00 for junior drivers.

All Entry Fees include 10% GST.

Payment to be made by Electronic Funds Transfer (EFT) into the account that will be on your confirmation email.

Please enter your **surname** as a reference followed by "**Motorkhana Entry**" and provide a copy of the Online Payment Receipt with entry at Documentation.

**All entries will be online only at [www.motorsport.org.au](http://www.motorsport.org.au) and must be accompanied by the requisite entry fee.**

The maximum number of competitors shall be 50, chosen from the first 50 in order of receipt of completed and fully paid entries.

#### 10. **RUNNING DETAILS:**

Scrutiny will be via the Motorsport Australia 'Self Scrutiny' and 'Vehicle Compliance' forms. These need to be filled out and sent to the Event Secretary prior to the event at [paheight@optusnet.com.au](mailto:paheight@optusnet.com.au).

**Drivers Briefing will take place at 9:45am. Competition starts at 10:00am.**

The rotation of the field will be notified at the Drivers Briefing.

#### 11. **DRIVERS:**

Drivers of vehicles without windscreens must wear appropriate eye-protection as per Motorsport Australia requirements. All drivers must attend the Drivers Briefing.

#### 12. **JUDGES OF FACT:**

An Official(s) shall be appointed to be the Judge of Fact, whose duty it is to decide when or whether an automobile has touched or passed a given line. Judges of Fact will be the Clerk of the Course, Stewards, Timers, Starters and Observers.

#### 13. **REFUSAL OF ENTRY:**

As per the NCR's an Entry for a competition held under these rules, other than an International Competition may be refused in accordance with the Supplementary Regulations relating to such competition, prior to the meeting and within three days after the date set for the close of entries.

#### **14. VEHICLE REQUIREMENTS:**

As per the Motorkhana Regulations, Schedule A and Group 4K. Fuel shall be in accordance with schedule G. Vehicles must be adequately muffled to comply with noise restrictions.

#### **15. TYRES:**

Only street tyres (DOT) are permitted for SEAC series points. No slicks, bar treads, block treads, winter treads, off road aggressive type tyres with a square shoulder will be permitted. No traction additives will be permitted. Spare tyres, which may be used during the event, shall be scrutinized along with the vehicle.

#### **16. PASSENGERS:**

Junior competitors may request a Motorsport Australia Speed Licensed or Superior. SEAC member as a passenger/instructor for the non-competitive component of the event. Approval must be given from the Clerk of the Course prior to any passenger entering a vehicle. Passengers must sign a "Passenger Entry Form" (even if they are also a driver on the day), and comply with the Supplementary Regulations, current MSPRA requirements.

#### **CLASSES:**

Classes for the "MOTORKHANA SERIES 2021" shall be standard or modified:

Class A:	Production Cars	up to	2300mm, wheel base, 2wd.
Class B:	Production Cars	2301mm	2575mm, wheel base, 2wd-EOD.
Class C:	Production Cars	2301mm	2575mm, wheel base, 2wd –EAD.
Class D:	Production Cars	2575mm	over, wheel base, 2wd
Class E:	4WD/AWD		
Class F:	Specials		
Class J:	Juniors		
Class NJ:	Novice Junior		
Master:	Additional class for Males 60+ and Females 55+ at the 1 <sup>st</sup> of January. One trophy for highest ranked.		

#### **Notes:**

1. Juniors are defined as being over 12 years but less than 18 years of age on the day of the first round (March 13<sup>th</sup>).
2. Novices are defined as junior competitors in their first year of competition.
3. All Persons driving a Special will compete in Class F.
4. Competitors may compete in two vehicles on two classes providing they have paid two entry fees.

#### **17. METHOD OF SCORING: A Handicap system will apply in 2021**

The handicap is applied before any penalties and is as follows:

Class F	no handicap
Class A	0.90
Class B	0.88
Class C	0.87
Class D	0.84
Class E	0.92

**Competitors will be scored on 4 out of the 5 rounds. Your worst round will dropped at the end of the season if you competed in all 5 rounds in the 2021 series.**

#### **18. AWARDS:**

1. A "Series Champion Award" will be presented to the competitor with the greatest number of accumulated points at the end of the series.
2. Aggregate series class awards will be made for first, second & third, providing competitor numbers justify such awards.

**19. VARIATIONS TO KHANACROSS REGULATIONS:**

Procedure & Penalties.

- (a) Clause 13.4 (viii) which deals with penalties for 'striking a marker', is varied with the addition of the words, "and significantly displaced from its original position".
- (b) Clause 13.4 (IV) that deals with reversing after crossing a designated finish line, the penalty is changed to "plus five seconds".
- (c) Every marker knocked carries a separate penalty of "plus 5 seconds".
- (d) Diagrams will be provided for each course.

**20. CATERING:**

No Catering at the venue.

**21. PROTESTS:**

Any protests must be lodged in accordance with the NCR's of the Motorsport Australia Manual.

**22. ABANDONMENT:**

The Organisers reserve the right to postpone or abandon the Event under the provision of NCR's of the Motorsport Australia Manual.

**23. COME & TRY:**

No "Come and Try" at this event.

**24. ALCOHOL, DRUGS AND OTHER SUBSTANCES:**

The holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of any drug or other banned substance and subject to a penalty for a breach of the Australian National Anti-Doping Policy and/or the Motorsport Australia Illicit Drugs in Sport (Safety Testing) Policy at [www.motorsport.org.au](http://www.motorsport.org.au). Consumption of alcohol in the paddock, pits or any other Reserved Area is prohibited until all Competition is concluded each day. The holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol by a Motorsport Australia Accredited Testing Official (CATO) in accordance with the Motorsport Australia Alcohol Policy at [www.motorsport.org.au](http://www.motorsport.org.au).

**25. MSPRA:**

This Event will include a Motorsport Passenger Ride Activity (MSPRA) which shall be run under and in accordance with the Motorsport Australia MSPRA Policy.
