ORGANISATION

- 11 1 NATURE OF THE EVENT**
- 1.1.1 The Event shall be known as the 2018 CAMS Australian Khanacross Championship, hereinafter referred to as 'The Event'.
- 1.1.2 The Event will be conducted as a **National Level Khanacross** held over two days, Saturday 9th and Sunday 10th June 2018 in line with the Event Schedule published in these Supplementary Regulations.
- 1.2 AUTHORITY**
- 1.2.1 The Event will be held under the FIA International Sporting Code including Appendices, the National Competition Rules (NCRs) of the Confederation of Australian Motorsport Ltd (CAMS), the CAMS Khanacross Regulations, these Supplementary Regulations, any Further Regulations, and any Bulletins or Instructions to Competitors which may be issued by the Organising Committee and approved by CAMS.
- 1.2.2 The Event will be conducted under and in accordance with the CAMS OH&S and Risk Management Policies, which can be found on the CAMS website at www.cams.com.au
- 1.2.3 Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the Event. Further details can be found in the CAMS Insurance Handbook, available at www.cams.com.au

- 1.8 ALTERATION TO, ABANDONMENT OR TERMINATION OF THE EVENT**
- 1.8.1 In accordance with NCR 59 of the current CAMS Manual or Motor Sport, the Organising Committee reserves the right to abandon, alter, postpone, or terminate the Event at any point.
- 1.8.2 The Organising Committee reserves the right to stop the Event at any time during competition if they consider it necessary, in the interests of safety or for any other reason.

EVENT DETAILS

2.1 EVENT LOCATION

- 2.1.1 The Event will be held at SEAC Motorsports ground located at Megaw Road, Mt Gambier SA 5290.
- 2.1.2 South East Automobile Motorsports ground is a grass/dirt motorsport complex and maps to the complex can be found at the end of these Supplementary Regulations or by searching for 'South East Automobile Club of SA 'Khanacross Track' in Google Maps.
- 2.1.3 No alcohol are to be brought into SEAC Motorsports ground.
- 2.1.4 Fuel is not available at SEAC Motorsports ground, however the town of Mt Gambier is 15 minutes' drive east, our sponsor is BP Gambier West, 195 Commercial Street West, Mount Gambier SA 5290.
- 2.1.5 Food and refreshments will be available on both days of the Event.
- 2.1.6 Camping will be available at South Eastern Automobile Motorsports ground, please advise if camping for the weekend. There is running water, toilets and shower facilities available.
- 2.1.7 Each entered vehicle will be allocated an area in the Pits of approximately wide enough for a tow vehicle, trailer, and car in single file. Any additional vehicles with the entry will be asked to park in the Spectator Parking Area.

2.2 EVENT FORMAT

- 2.2.1 The Event will consist of a minimum of six (6) tests.
- 2.2.2 Each track may be run in a forward and reverse direction.
- 2.2.3 Course markers for the Event may include flags, witches' hats, tyre bundles, and bunting
- 2.2.4 Electronic timing will be used to 0.01 second with a manual backup.
- 2.2.5 Passengers in vehicles will not be allowed whilst competing except when required for any Driver aged 12 or 13 years old.
- 2.2.6 At the end of competition on Sunday, a 30-minute Parc Ferme will be in effect to allow time for any Protests to be lodged. Vehicles may be loaded onto trailers however they may not leave the venue for the duration of the Parc Ferme.

EVENT ENTRIES

3.1 ENTRIES

- 3.1.1 Entries open and close as per the Event Schedule published in these Supplementary Regulations.
- 3.1.2 The Event is open to current financial members of all CAMS affiliated car clubs.
- 3.1.3 All Drivers shall hold, as a minimum, a current CAMS Non-Speed (Level 2NS) or Junior Non Speed (Level 2NSJ) competition License.
- 3.1.4 Minimum age for Drivers is 12 years of age. Drivers aged 12 and 13 years old must be accompanied by an experienced Instructor (who may also be a Competitor), as approved by the Clerk of the Course Entries from drivers under 18 years of age on the first day of competition countersigned / consented to by a Parent or Legal Guardian.
- 3.1.5 All Entries to the Event are to be made on the Entry Form provided and sent, together with the appropriate Entry Fee, to the official mailing address, or emailed to the Event Secretary online entry available at www.seacsa.com.
- 3.1.6 Cheques and money orders are to be made payable to South East Automobile Club of SA.
- 3.1.7 Any direct deposit payments are to be made to the following Account:

Entries will be accepted in order of receipt of completed entry forms with correct money
- 3.1.8 There will be a limit of sixty (60) Entries accepted in order of receipt of fully complete Entry Form accompanied by (proof of) payment.
- 3.1.9 The maximum number of Drivers per vehicle will be four (4).
- 3.1.10 The Organising Committee reserves the right to refuse Entries in accordance with NCR 83 of the current CAMS Manual of Motor Sport.

3.2 ENTRY FEES

- 3.2.1 The Entry Fee for the Event will be \$100.00 for Adults and \$60.00 for Juniors.
- 3.2.2 Entrants are deemed a Junior if they are between 12 and 18 years of age on the first day of competition.
- 3.2.3 An Entrant may claim a refund of their Entry Fee if the Entry is withdrawn in writing (including email) received not later than 5:00pm on Thursday 7 June 2018.

3.3 DRIVER BRIEFING

- 3.3.1 A Driver Briefing will be held at 2:00 pm on Saturday 9 June and at 9:00am on Sunday 10 June in front of the Event Headquarters Office.
- 3.3.2 It is required that all Drivers be present for the entire duration of the Briefing and sign the Drivers sign-on sheet as proof of attendance.
- 3.3.3 Failure to attend the Briefing will be referred to the Event Stewards who may impose a penalty up to and including exclusion.

DOCUMENTATION AND SCRUTINY

4.1 DOCUMENTATION

- 4.1.1 Documentation will be held at the Event Office during the times outlined in the Event Schedule as published in these Supplementary Regulations.
- 4.1.2 It is the Driver's responsibility to ensure they arrive at the venue with enough time to complete Documentation and Scrutiny. Any Driver who arrives late and does not complete Documentation and Scrutiny before they close may not be allowed to compete.
- 4.1.3 Drivers will be required to complete documentation before attending Scrutiny.
- 4.1.4 At Documentation, Drivers will be required to present:
- Current CAMS competition license
 - Current CAMS affiliated club membership card

4.2 SCRUTINY

- 4.2.1 Scrutiny will be held in the area adjacent to the Event Office during the times outlined in the Event Schedule as published in these Supplementary Regulations.
- 4.2.2 Vehicles must be presented for Scrutiny in a 'ready to run' condition.
- 4.2.3 All vehicles must comply with Schedule A of the current CAMS Manual of Motor Sport and all vehicles defined as a special by Group 4H must also comply with Motorkhana Cars—Group 4H requirements in the current CAMS Manual of Motor Sport.
- 4.2.4 All vehicles must be adequately muffled to not exceed a noise limit of 95dB(A) and also have fitted securely, a fire extinguisher of at least 1 kg capacity and complying with Schedule H of the current CAMS Manual of Motor Sport.
- 4.2.5 Vehicles may be fitted with up to 6 (3 Pairs) of Forward Facing lights. (A light bar is considered 1 pair)
- 4.2.6 If a vehicle has been issued a Log Book from CAMS, this must be presented to the Chief Scrutineer.
- 4.2.7 The Chief Scrutineer shall rule on the acceptability of any vehicle to compete in the Event and the class in which it shall compete.

4.3 HELMETS AND APPAREL

- 4.3.1 All Drivers must wear a Helmet as listed in Schedule D of the current CAMS Manual of Motor Sport.
- 4.3.2 All apparel worn by Drivers must be of a non-flammable material and comply with Schedule D of the current CAMS Manual of Motor Sport.
- 4.3.3 All Drivers must wear an approved safety harness or seatbelt during competition in accordance with Schedule I of the current CAMS Manual of Motor Sport.
- 4.3.4 All drivers of open vehicles or vehicles that have had the windscreen removed, must wear goggles or a visor to Australian Standard AS1609/1981. Goggles with glass lenses, whether laminated or not, are unacceptable.

Note: Classes A, B, C, D, E and G will include modified and standard sub-classes.
 Standard = production base vehicles on street tyres only
 Modified = Rally cars, race cars and production based vehicles on rally tyres.
 The Chief Scrutineer shall be the sole arbiter in determining which tyre is eligible for each sub-class

Note: Vehicles classified as specials in Group 4H must not have more than two driven wheels or more than two steered wheels.

4.5 CATEGORIES

4.5.1 Competition categories will be

- Category J— Juniors
- Category L—Ladies

Note: Nomination in a category does not preclude a Driver from competing for class awards.

PENALTIES AND PROTESTS

5.1 JUDGES OF FACT

5.1.1 In accordance with NCR 181 the following Officials are deemed to be Judges of Fact

- all Officials of the Event are deemed Judges of Fact in regard to the correct application of penalties as set out in Section 5.2 (Penalties) of these Supplementary Regulations and the CAMS Khanacross Regulations including:
 - not wearing seat belt / safety harness, helmet, or safety clothing;
 - hitting or bypassing course markers (which may include flags, bunting, witches' hats, tyre bundles, barriers, or chicanes);
 - short cutting the course;
 - driver conduct
- Scrutineers are deemed Judges of Fact of the following:
 - vehicle in un-roadworthy condition;
 - vehicle with accident damage;
 - eligibility of vehicles;
 - vehicle safety equipment;
 - driver apparel
- Medical Officers are deemed Judges of Fact of the medical condition of any Crew Member or Team Member.
- Timekeepers are deemed Judges of Fact in regards to correctness and accuracy of recorded times.

5.2 PENALTIES

5.2.1 The following penalties will apply during the Event as per the current CAMS Khanacross Regulations

- striking a course marker or flag (including garage boundary flag)
 - plus five (5) seconds per marker or flag
- failing to stop completely at the finish of a course
 - slowest time plus five (5) seconds
- finishing a course with the car stopped but completely outside the garage
 - slowest time plus five (5) seconds
- reversing after crossing the designated finish line with any part of the vehicle
 - slowest time plus five (5) seconds
- failing to complete a test
 - slowest time plus five (5) seconds
- wrong direction or any procedure other than that specified as the correct procedure for completing that course
 - slowest time plus five (5) seconds
- finishing a course with part of the car outside the garage boundaries
 - plus five (5) seconds and plus five (5) seconds per marker or flag
- failure to attempt a test
 - slowest time plus ten (10) seconds

Note: When the slowest time plus five (5) seconds exceeds double the fastest time, the time to be applied shall be double the fastest time

Note: When establishing either fastest time or slowest time, no time which includes any penalty, or for whom the driver had a passenger, will be used

5.3 DRIVER CONDUCT

5.3.1 Any Driver acting in an irresponsible way may be excluded from the Event and their vehicle may not

be allowed to continue in the competition, meaning any other Driver entered in the vehicle may also be excluded. They will also be reported to the Event Stewards or may decide to impose additional penalties

- 5.3.2 Prohibited behaviour includes excessive speed in any Non-Competition Areas, any abuse, physical or verbal, towards any Official, or not obeying a reasonable direction from an Official

5.4 PROTESTS

- 5.4.1 All Protests must be lodged in accordance with Part XII of the NCRs in the current CAMS Manual of Motor Sport.

PROHIBITED SUBSTANCES

6.1 ALCOHOL, DRUGS AND OTHER SUBSTANCES

Any holder of a CAMS 'Competition' or 'Officials' license (or equivalent license issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' license (or equivalent license issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.

AWARDS

7.1 AWARDS

- 7.1.1 A presentation shall be held outside the Event Office as per the Event Schedule published in these Supplementary Regulations where the awards or trophies outlined below will be presented
- 1st, 2nd and 3rd Outright—Trophies
 - 1st in each class—Trophies
 - 1st Junior—Trophy
 - 1st Lady—Trophy
- 7.1.2 Awards will depend on entries in each class, eg: 1 – 3 entries = 1st in class trophy;
4 – 5 entries = 1st & 2nd in class; over 6 entries in class = 1st, 2nd & 3rd in class.
- 7.1.3 The Organising Committee reserves the right to add to these awards
- 7.1.4 All Competitors and their Families will receive a complementary Sunday evening meal after presentations. Please add your approximate number of family for meals eg: Adults and Children on the entry form.

8.0 PASSENGERS

This Event will include a Motor Sport Passenger Ride Activity (MSPRA) which shall be run under and in accordance with the CAMS MSPRA Policy.

- (a) A briefing must be attended by each Driver and Passenger (and guardians of each Passenger if Passenger is under 18 years of age) conducted by the Clerk of the Course prior to the MSPRA commencing.
- (b) Passengers MUST:
- i. wear the same protective gear as a Driver
 - ii. Be fitted and restrained as required for each Automobile with consideration for their physical attributes
 - iii. Complete a Passenger Ride Entry Form and disclaimer
 - iv. Drivers must fill out a Passenger Ride Entry Form to ride as a passenger.
 - v. Be at least 12 years of age
- (c) Vehicles and Apparel used must pass Scrutiny.
- (d) Vehicles shall only carry one Passenger at a time, unless otherwise approved by CAMS.
