## **Event Supplementary Regulations**

These Event Supplementary Regulations are to be read together with the 2018 SEAC Rally Sprint Series Regulations

### 1. THE EVENT

- 1.1. The Event shall be known as the "2018 LCORC Rally Sprint" (hereafter referred to as the Event) will be a round of the 2018 SEAC Rally Sprint Series and will be conducted at Moorex Park Rallysprint.
- 1.2. The length of the rally will be approximately 45 kms, including 6 stages which have a total competitive distance of approximately 30 kms. All special stages are of a sand/dirt surface, held on private property.
- 1.3. The Event is a Club Stage 1 Rally Sprint.

- 7.1. Crews shall comprise of either one or two persons both being the holders of a minimum CAMS Level 2S(J) licence. The minimum age for Drivers and Co-Drivers in Rally Sprints is 14 years. Please note that Junior Drivers will need an experienced Co-Driver and approval from the Clerk of the Course prior to commencing competition.
- 7.2. Maximum number of Drivers per vehicle will be 2.

### 9. SCRUTINY

- 9.1. Scrutiny will be performed between 8.00am 9.00am on Saturday 23<sup>rd</sup> June outside of Rally headquarters at Moorex property.
- 9.2. No late scrutineering will be done.
  - 9.3. At Scrutineering Competitors with be required to present:
  - Vehicle Log Book ( if issued to vehicle)
  - Helmets
  - The car in a "ready to rally" condition, including driving lights (if they will be used).
- 9.4. Vehicles must arrive at the Scrutiny Venue in **READY TO COMPETE CONDITION** in compliance with Schedule A and Schedule R, of the current CAMS Manual of Motor Sport.
- 9.5. Apparel, including helmets, shall comply with Schedule D of the current CAMS Manual.

### 10. DOCUMENTATION

- 10.1. The following items shall be presented and checked by both Driver and Co-Driver at Scrutiny:
  - Current LCORC membership card
  - Both Current CAMS Competition Licence,
- 10.2. CAMS Vehicle Log Book (if issued to vehicle)

### 11. SERVICING AND REFUELLING

- 11.1. Servicing is only allowed in the designated service area as indicated on the day.
- 11.2. The maximum distance between refuelling will be approximately 8.0km competitive.
- 11.3. Re-fuelling is only allowed in the designated re-fuel area.
- 11.4. There is no fuel available the Event.

### 12. ALCOHOL, DRUGS AND OTHER SUBSTANCES

Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.

### 13. ALTERATION TO, ABANDONMENT OR TERMINATION OF THE EVENT

Event Organisers reserve the right to cancel, abandon or postpone the event in accordance with NCR 59 of the current CAMS Manual.

### 14. COMPETITORS BRIEFING

Competitors Briefing will be held at 9.15am. All Competitors are reminded that they must present themselves for Drivers Briefing. Penalty for non-attendance will result in Exclusion from the Event.

### 15. PROTESTS

Protests must be lodged in accordance with Part XII of the current CAMS Manual.

### 16. AWARDS

- 16.1. Trophies will be awarded to:
  - Outright Placing for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup>.
  - 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Novice Driver and Navigator

Motor Sport Activities are inherently dangerous recreational activities and there is significant risk of injury, disability or death. If you do not wish to be exposed to such risks, then you should not participate in the Motor Sport Activities. I acknowledge that:

- the risks associated with attending or participating in Motor Sport Activities include but are NOT LIMITED to the risk that I may suffer harm as a result of:
  - motor vehicles (or parts of them) colliding with other motor vehicles or persons or property;
  - others participants acting dangerously or with lack of skills;
  - high levels of noise exposure;
  - acts of violence and other harmful acts (whether intentional or inadvertent) committed by persons attending or participating
    in the event; and
  - the failure or unsuitability of facilities (including grand-stands, fences and guard rails) to ensure my safety.

### **EXCLUSION OF LIABILITY, RELEASE & INDEMNITY**

In exchange for being able to attend or participate in the Motor Sport Activities, I agree:

  - b) any physical or mental injury (including the aggravation, acceleration or recurrence of such an injury);
  - c) the contraction, aggravation or acceleration of a disease;
  - d) the coming into existence, the aggravation, acceleration or recurrence of any other condition, circumstance, occurrence, activity, form of behaviour, course of conduct or state of affairs:
    - i. that is or may be harmful or disadvantageous to me or the community; or
    - ii. that may result in harm or disadvantage to me or the community,

howsoever arising from my participation in or attendance at the Motor Sport Activities;

- to **indemnify and hold harmless and keep indemnified** the Entities to the maximum extent permitted by law in respect of any Claim by any person; and
- to attend at or participate in the Motor Sport Activities at my own risk. I understand that:
  - nothing in this document excludes, restricts or modifies any rights that I may have as a result of significant personal injury that is
    caused by the Reckless Conduct of the Entities as the supplier of the Motor Sport Activities / Recreational Services;
  - nothing in this document prevents the Entities from relying on any laws (including statute and common law) that limit or preclude their liability:
  - nothing in this document excludes any term or guarantee which under statute cannot be excluded; however the liability of the Entities is limited to the minimum liability allowable by law;
  - nothing in this document precludes me from making a claim under a CAMS insurance policy where I am expressly entitled to make a claim under that insurance policy; and
  - CAMS has arranged some limited personal injury insurance coverage which may provide me with some protection for loss, damage or injury that I may suffer during my participation in the Motor Sport Activities.
